From the Desk of the Town Council Liaison

Carla Condon, Liaison to the Corte Madera Chamber of Commerce

Summer is just around the corner and the hanging baskets and the median strips are all in bloom and look absolutely beautiful. Last month, our beloved Director of Public Works-Field Maintenance Operations, Kevin Kramer, who was responsible for the incredible landscaping, retired after 33 years of serving our Town with such skill and dedication. As you can see, his loyal staff is carrying on, keeping our town looking great. I continue to receive so many compliments about how beautiful Corte Madera is, over other locales in Marin. We have a lot to be proud of.

We have welcomed a new addition to our staff, Daria Carrillo, our new Director of Finance who is working hand in hand with George Warman, our Director of Administrative Services. Daria was formerly the Finance Director for the City of San Anselmo. The Council has been working diligently and effectively with Town Manager Todd Cusimano and Staff to reduce our pension liabilities. We have made such strides that the Town has been recognized for the significant measures it has taken to decrease that debt which is burdening local, state and federal

governments, as well as private companies throughout the country. We're in a good financial position and continue to be mindful of and prudent in our spending.

Appropriations have been made to necessary public works projects to maintain our sound infrastructure. Corte Madera stands above other jurisdictions in our aggressive practice to fix things before the conditions become so poor that the repair costs become inordinately high. Because of the ongoing pump station maintenance, we avoided heavy flooding and damage during the enormous rainfall that we experienced in the beginning months of the year. We are now seeing road improvements made throughout the town.

Many major projects are coming before the Town, more at once than I can ever recollect. Right now, we're scheduled to consider the new Restoration Hardware building; the Corte Madera Inn rebuild; Marin Country Day School expansion; expansion of the Marin Montessori School; construction of 16 rental homes with 8 "second units" on Robin Drive; the Budget Motel re-design and the Scandinavian Designs proposal for the theater location. Most of these

projects will be holding public hearings before going to the Planning Commission and/or Town Council and I encourage you to attend those meetings to give your input. You can contact our wonderful Town Clerk, Rebecca Vaughn (rvaughn@ tcmmail.org) to receive notifications of those hearings.

At the end of June, barring any unforeseen events, the Tam Ridge is scheduled to be completed and ready for occupancy. For those of you who missed the Council meeting when representatives from the developer spoke to update the community on the setbacks experienced during construction, we were informed of the enormous measures that were taken to essentially de-construct the building to cure any and all deficiencies so the current structure is of the highest quality of construction and in total compliance with

codes. We understand there are many people interested in making Tam Ridge their new home and we will all be happy to see the end of the construction!

Age-Friendly Corte Madera and the Twin Cities Village have been conducting the fabulous Third Wednesday Speakers Series, garnering increased attendance with each event. Please check the schedule at www.agefriendlycortemadera. com or www.marinvillages. org. Both organizations are offering tremendous services to our older residents and their families.

Please remember that it is funding that keeps our Town looking so beautiful, provides quality programs through our Park and Rec Department and maintains our superior infrastructure. Sales tax and transient occupancy tax (TOT), the money collected from visitors staying at our hotels, are what largely support the services and amenities we enjoy, including our annual 4th of July Parade.

Speaking of the 4th of July Parade, don't miss it! It's great fun to participate whether it be with your family, your pet, alone or with a group. Julie Kritzberger, Executive Director of our Chamber of Commerce, never fails to do an amazing job of making the 4th so much fun with the spectacular parade and food, fun and entertainment in Town Park. Unpaid Interns: No Such Thing as a Free Lunch

As the daylight lingers longer into the evening and bathing suits replace down winter jackets, we are often asked some variation of the following question: "Do I really have to pay our summer clerk? Can't I just hire her as an unpaid intern? She'll gain incredible experience and meet lots of fabulous people (including me!) -- so isn't that compensation enough?!?"

Short Answer. Our long, eloquent answer is below, but if you prefer to cut straight to the chase, the short answer is: No, not unless she really, truly, in-all-honesty is an actual "trainee" (which is a fairly rare phenomenon in most business settings).

Longer Explanation. The California Division of Labor Standards Enforcement (DLSE) issued an **opinion** letter in 2010 to address the stringent requirements employers must meet in order to have unpaid interns under California law. This DLSE opinion letter confirmed that California follows the federal Department of Labor's (DOL) same strict factors in analyzing the classification of interns. The DLSE explained that if all six of the following criteria apply, the company can consider the intern as a "trainee," not an employee, under California law:

1. The training, even though it includes actual operation of the facilities of the employer, is similar to that which would be given in a vocational school (i.e., a curriculum is followed and the student is under continued and direct supervision either by representatives of the school or by employees of the business); and

- 2. The training is intended to benefit the trainee/student rather than to meet the labor needs of the business; and
- 3. The trainee/student does not displace a regular employee, does not fill a vacant position, does not relieve an employee of assigned duties, and does not perform services that, although not ordinarily performed by employees, clearly are of benefit to the business; and
- 4. The employer that provides the training derives no immediate advantage from the activities of the trainee/student and, on occasion, the employer's operations may actually be impeded; and
- 5. The trainee/student is not necessarily entitled to a job at the conclusion of the training period; and
- The employer and the trainee/student understand that the trainee/ student is not entitled to wages for the time spent in training.

Essentially, the six criteria require that the internship

be of benefit to the intern, with the employer gaining no benefit. In practice, this standard is very difficult to meet - even for government and nonprofit agencies.

Hollywood provided us with a highly-publicized example of this when Fox Searchlight hired unpaid interns to work on the set of the movie Black Swan. In its published opinion, the

federal district court found that the unpaid interns should have been classified as employees covered by the Fair Labor Standards Act, explaining that the interns "worked as paid employees work, providing an immediate advantage to their employer and performing low-level tasks not requiring specialized training." The court also noted: "The benefits they may have received - such as knowledge of how a production or accounting office functions or references for future jobs - are the results of simply having worked as any other employee works, not of internships designed to be uniquely educational to the interns and of little utility to the employer."

As Fox Searchlight learned, improperly classifying employees as unpaid interns can impact a company's finances and reputation. Unless they legitimately meet all six of the specified requirements for "trainees," work-

ers should be classified as employees, even if they wear flip-flops to work and carry a backpack. If the DLSE finds that an employer was improperly classifying employees as unpaid interns, it can require the employer to pay significant damages and penalties, including unpaid wages, overtime, and waiting time penalties. Current or former interns can also bring a lawsuit against an employer violating these rules, which means more cost, hassle, and headache for an employer, as well as the business uncertainty any litigation defendant faces. If you are in the small

minority of organizations where an intern's role will unquestionably meet the six criteria described above, we recommend that you put the expectations in writing, explaining in clear language that the intern is not entitled to a job at the conclusion of the training period and will not be paid for the training time. We also recommend that you closely monitor the intern's actual job duties and roles throughout the course of their work and ensure that the intern's supervisors understand the specific requirements to maintain their status as an unpaid

intern. However, in most instances, what many people might consider as an "intern" should technically be classified as a paid employee because the vast majority of intern positions will not meet the stringent criteria.

Conclusion. We all delight in finding a bargain, most especially those rare instances when we can acquire value from something that we don't even have to pay for. But in the employment arena, as in much of life, the trite cliché of the illusory free lunch rings true: there is no such thing as a free employee (unless she really, truly qualifies as a "trainee").
