The Parade will begin on Friday, July 4th, 2025 at 10:30 a.m. from Redwood High School. Parade Line-Up will be from 8:30 to 10:00 a.m. Once your application has been accepted you will receive your acceptance letter and your Parade Number shortly after June 27th.

The Parade route runs along Doherty Drive then left on Magnolia to Redwood/Tamalpais Drive, along Tamalpais Drive and ends at Corte Madera Town Center.

There will be judges viewing stands in Larkspur along Magnolia and another viewing stand will be in front of the Corte Madera Community Center on Tamalpais Drive in Corte Madera. If you wish to give a small performance in front of the reviewing stands, it must not exceed one (1) minute.

PARADE RULES & INFORMATION

- 1. Parade assembly is 8:30 until 10:00 a.m. Entries not in position will go to end of parade.
- 2. All entries, including commercial, must enhance the parade and be decorated in a patriotic theme.
- 3. Nothing can be tossed from a parade entry to spectators along the parade route or curbside. Distribution of information, candy or favors by pedestrians accompanying the float is permitted by walking along the audience edge in a manner which discourages spectators from running into the roadway.
- 4. All drivers must carry current California driver's license and proof of insurance.
- 5. Parade Participants must be family friendly and appropriate for all ages.
- 6. All persons riding motorcycles, bicycles, scooters, and skateboards must wear helmet.
- 7. All units must keep in a forward position.
- 8. Time in Judges area will be (1) minute. Judging points will be lost for failure to comply.
- 9. Instructions and directions from Parade Officials and volunteers must be obeyed.
- 10. Parade Committee reserves the right to refuse or remove any entry not in keeping with the dignity of the Parade.
- 11. Parade Entrants must comply with information entrant submitted on their Parade Application or will be removed from Parade.
- 12. Units shall bear no advertising other than the name of the sponsor.
- 13. Units with parade participants in trucks must be seated at all times. No one is allowed to ride on running boards, hoods, roofs, fenders or external platforms.
- 14. Parade entries must not exceed 75 feet in length and no more than 50 participants.
- 15. Breakdowns must pull out of the parade route immediately and may return, if operable, at the end of the Parade.
- 16. No alcoholic beverages shall be consumed during the Parade.
- 17. No more than six signs per unit.
- 18. If you aren't registered the day of the parade you will not be able to participate.
